

INFORMS PLANNED GIVING

As an INFORMS

It can take many forms, including bequests, gifts of life insurance, and charitable remainder trusts. BEQUEST 🕪

Bequests are the easiest form of a planned gift and can be made by naming INFORMS as a beneficiary in your will. Your bequest can be made as a specific dollar amount or asset, a percentage of your estate, a gift from the residue of your estate, or a beneficiary designation of certain assets. Naming INFORMS as a beneficiary will not disrupt your income and may allow your estate to benefit from a charitable estate tax deduction.

LIFE INSURANCE



You can name INFORMS as the beneficiary of a life insurance policy that is no longer needed for its original purpose. INFORMS can also be made one of the beneficiaries of an active policy. If you have a policy that pays annual dividends, you may assign those dividends as a charitable gift to INFORMS and receive an income tax deduction for the value of the dividends. You may also transfer ownership of a policy to INFORMS and then deduct any premiums that you continue to pay.

CHARITABLE REMAINDER TRUST



With the assistance of a lawyer, you may wish to establish a Charitable Remainder Trust, which can provide you with income for life with a gift to INFORMS upon death or termination of the trust. More information about all three options can be found at informs.org/About-INFORMS/Donate.
